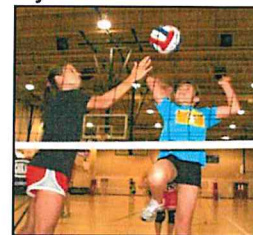


# Big Bear Valley Recreation and Park District Youth Spring Volleyball 2023
